In 2008 he became CEO of Banque Postale Gestion Privée, a joint venture of Oddo BHF and La Banque Postale. In 2011 he was appointed Deputy CEO of Oddo BHF Asset Management. Since 2019 he has been a member of the Executive Board of Montpensier Finance.
